** Access hours must include 2 hours for vendor set-up and 1 hour for vendor tear-down; additional time can be purchased for \$200/30 minute intervals (limits apply).

*** The Farm may agree to waive the tent requirements for weddings of 150-175 if client incorporates space saving ideas (e.g. DJ vs band, stations vs seated meal)

**** We can comfortably accommodate up to 135 guests at winter weddings with required space saving ideas.

Services **NOT** Included in The Farm’s Wedding Packages

As explained above, Client must purchase wedding venue and reception site, catering, bar services, month-of-wedding coordination. The following are additional services often used by wedding Clients that are not provided by The Farm. We’re happy to provide wedding Clients with our carefully vetted list of preferred vendors, but Clients must book with these vendors directly.

• Officiant	• Photographer/Videographer
• DJ/Musicians	• Transportation
• Hair/Make-up	• Decorating services (use and placement of items from The Farm’s Décor Inventory are included – fees apply to non-Farm items)
• Florist (but consider The Farm if you’re looking for informal floral arrangements from our Farm Garden)	• Full Wedding Planning (see our Month-of-Coordination overview to understand what services are included in our wedding packages)

How to Use Your Access Hours

- **Access Hours:** the number of access hours is based on the purchased wedding package.
- **Access Hours are strictly enforced.** No items can be stored at Event Center outside of set access hours.
- **Purchase Additional Hours:** Clients can purchase additional hours and add them to the front end of this schedule to extend time
- **Wedding Rehearsal:** Clients can hold a one-hour rehearsal before 5:00pm during the week of the wedding (provided no other events are booked for that date/time). If more Rehearsal time is necessary or if the Rehearsal is held after 5pm, client will be charged per the Building Rental Agreement.
- Here is a suggested timeline for our 8- and 12-hour packages.

Miscellaneous Fees

These fees are rarely assessed but we wanted to be transparent about them:

• Labor Fee (e.g., set-up/tear down of non-Farm equipment)	\$40/hour	• Late Payment Fee (per invoice)	\$50
• Excessive Cleaning Fee	\$100/hour	• Rejected Payment Fee (per invoice)	\$50
• Damage Fee	Cost of Repairs	• Additional/Primetime Rehearsal Time	\$350/hour
• Pickup/Delivery Fee (Fee for each vendor pick-up or delivery outside of Access Period)	\$100/vendor/day	• Illegal Celebration Fee (see Exhibit A of Rental Agreement) Fee applied per item PLUS “Excessive Cleaning Fee”	\$350 / item
• Changes to event plans after 30-day Meeting (causing redesigns)	\$100/hour	• Kitchen or Bar late change fees, e.g. menu changes after 30-day meeting or guest count changes after 14-day deadline	\$500 plus food
